- 1. The Agency shall be responsible to pay compensation for injury/death caused, to your operating staff/third party in the event of any accident while on Kendra's duty. The Kendra will not be held responsible for any such mishap or liable for compensation.
- 2. The Firm shall be solely responsible to comply with all the provisions of Motor Vehicle Act and all other laws, rules guidelines, etc. as applicable from time to time in respect of plying of vehicles.
- 3. Kendra uses the vehicle for travelling across the state whenever needed. During outside destination, accommodation of driver, food, parking will be arranged by them.
- 4. The rates will not be increased during the contract period before completion of 2 years. However, in case of fuel charges etc. the request may be considered by the Kendra.
- 5. It will be responsibility of the firm to submit hiring of vehicle bills to Kathak Kendra. Kendra within 15 days of completion of journey. The payment for which will be made within 15 working days subject of availability of funds.
- 6. Payment of toll, parking etc. is subject of submission of receipt only.
- 7. In the event of any urgent official business, the car will have to be provided on holidays for which advance information shall be given.
